- 3. Finance Committee Update by Vic Montalbo
 - a. Account is presently at \$4,544.74 with another \$494.69 check received by Town
 - b. Vic is recommending that we consider a mail box, address just for the LDC
 - c. Noted that we do not yet have a debit card
 - d. Seeks approval to pay bill from H. Sicherman, \$5,273.70. This had been approved by the Board to apply for this payment, due from the Jacobs project, but had not approved payment to H. Sicherman.

- 4. Discussion regarding possible agreement with Consultant H. Sicherman
 - a. Attorney O'Toole passed around a modified potential agreement, with modifications.

 - a. noted that the subrecipient agreement with Town needs work between attorneys
 - b. Attorney handed out a listing of the documents required to complete this project, mostly completed, but some work needed before closing.
 - c. Attorney noted that the Board needs to approve or dismiss the requirement to have Chris Pellicano sign a personal guarantee. Noted that he has only 2% ownership.
